FINDINGS:

1. The Monterey County Board of Supervisors established the Big Sur Multi-Agency Advisory Council by Resolution No. 86-443 on July 8, 1986.

2. The Council has functioned well to facilitate communication and coordination among the governmental agencies that have jurisdiction with the Big Sur Area.

3. However, this Board of Supervisors has felt the need to include the California State Assembly Member of the 27th Assembly District as an official member of the Council to broaden the communication and coordination which as served the Big Sur area of Monterey County so well.

4. Additionally, this Board wishes to correct the titles of the members from the U.S. Forest Service and the State Parks and Recreation Department to accurately reflect the level of participation from both agencies.

NOW, THEREFORE, BE IT RESOLVED that the Monterey County Board of Supervisors hereby amends its Resolution No. 86-443 by amending Section 2 to read as follows:

2. MEMBERSHIP

- Member 27th Assembly District, California State Legislature
- Forest District Ranger for Monterey Ranger District for the Los Padres National Forest
- Regional Director, Monterey Park District, for the State Department of Parks and Recreation
- District Director, District 5, for the State Department of Transportation
- District Director, Central Coast District, for the California Coastal Commission
- Member of the Monterey County Board of Supervisors
- Director of Planning & Building Inspection, Monterey County
- President, Coast Property Owners' Association of Big Sur
- President, Big Sur Chamber of Commerce
- Resident of Big Sur Area appointed for a two-year term by the Monterey County Board of Supervisors

The appointed Resident member shall be subject to recall from the Council if the Board of Supervisors are so petitioned by more than 50% of registered voters within the boundaries of the Big Sur Coast Planning Area. In the event of such a recall, a replacement shall

be appointed by the Board of Supervisors within 30 days.


