

**AMENDMENT No. 4 TO PARAMEDIC SERVICE PROVIDER AGREEMENT  
BETWEEN  
COUNTY OF MONTEREY AND  
CITY OF MONTEREY**

**THIS AMENDMENT No. 4** is made to the Paramedic Service Provider Agreement ("AGREEMENT") by and between the City of Monterey hereinafter referred to as "PROVIDER," and the County of Monterey, a political subdivision of the State of California, acting through its Emergency Medical Services Agency (EMSA), hereinafter referred to as "COUNTY."

**WHEREAS**, on or about September 4, 2018, COUNTY and PROVIDER entered into an AGREEMENT for the provision of paramedic services in the County of Monterey for a period from September 4, 2018, to January 31, 2020; and

**WHEREAS**, on or about February 13, 2020, COUNTY and PROVIDER executed AMENDMENT #1 to extend the AGREEMENT on the same terms and conditions for a period of two (2) years to January 31, 2022; and

**WHEREAS**, on or about March 10, 2022, COUNTY and PROVIDER executed AMENDMENT #2 to extend the AGREEMENT on the same terms and conditions for a period of five (5) years to January 31, 2027; and

**WHEREAS**, on or about March 18, 2024, COUNTY and PROVIDER executed AMENDMENT #3 to amend the language of Section 3.2; and

**WHEREAS**, COUNTY and PROVIDER wish to amend the AGREEMENT to modify Section 3.2 to add language addressing additional agreements for the provision of first response Advanced Life Support (ALS) first response in other geographic areas pursuant to other agreements between COUNTY and PROVIDER.

**NOW THEREFORE**, COUNTY and PROVIDER hereby agree to amend the AGREEMENT in the following manner:

1. Amend Section 3.2 to read as follows:

3.2 PROVIDER may also provide Basic Life Support and Advanced Life Support on automatic aid and mutual aid calls within and outside of Monterey County. This Agreement shall not be construed to allow PROVIDER to provide Advanced Life Support on a routine or long-term basis in areas other than within the "Primary Service Area" identified on the map and attached as Exhibit A until patient care is transferred to another authorized provider or authorized receiving facility, pursuant to EMS Agency policies and procedures. Under the umbrella of providing mutual aid, the PROVIDER may on occasion have a paramedic with current Monterey County paramedic accreditation act in a paramedic capacity while working in other areas of the county when the approved county "Paramedic Provider Authorized Stock (4010)" equipment arrives at the scene of an emergency incident. Notwithstanding the foregoing, the parties acknowledge that other agreements have been or may be entered into between PROVIDER and

the County regarding other service areas and such agreements are not abrogated by this Agreement. PROVIDER shall be permitted to provide Advanced Life Support in other service areas in accordance with other applicable agreements.

- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT, AMENDMENT No. 1, AMENDMENT No. 2, and AMENDMENT No.3,

shall continue in full force and effect.

- 3. A copy of AMENDMENT No. 4 shall be attached to the original AGREEMENT dated September 4, 2018, and shall be incorporated therein as if fully set forth in the AGREEMENT.

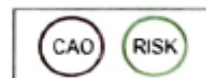

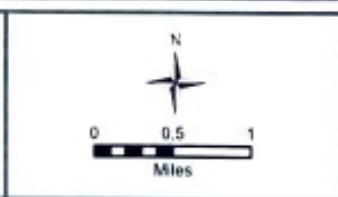
