

**AMENDMENT No. 4 TO PARAMEDIC SERVICE PROVIDER AGREEMENT  
BETWEEN  
COUNTY OF MONTEREY  
AND  
PEBBLE BEACH COMMUNITY SERVICES DISTRICT**

**THIS AMENDMENT No. 4** is made to the Paramedic Service Provider Agreement (“AGREEMENT”) by and between the Pebble Beach Community Services District hereinafter referred to as “PROVIDER,” and the County of Monterey, a political subdivision of the State of California, acting through its Emergency Medical Services Agency (EMSA), hereinafter referred to as “COUNTY.”

**WHEREAS**, on or about July 1, 2018, COUNTY and PROVIDER entered into an AGREEMENT for the provision of paramedic services in the County of Monterey for a period from July 1, 2018 to January 31, 2020; and

**WHEREAS**, on or about February 13, 2020, COUNTY and PROVIDER executed AMENDMENT #1 to extend the AGREEMENT on the same terms and conditions for a period of two years to January 31, 2022; and

**WHEREAS**, on or about March 10, 2022, COUNTY and PROVIDER executed AMENDMENT #2 to extend the AGREEMENT on the same terms and conditions for a period of five (5) months to July 31, 2022; and

**WHEREAS**, on or about July 26, 2022, COUNTY and PROVIDER executed AMENDMENT #3 to extend the AGREEMENT on the same terms and conditions for a period of two years and eleven (11) months to June 30, 2025; and

**WHEREAS**, COUNTY and PROVIDER wish to amend the AGREEMENT to extend the AGREEMENT on the same terms and conditions for a period of three years to June 30, 2028 and to change reference to California Code of Regulations, Title 22, Section 100168(b)(4) to reflect the correct section.









**NOW THEREFORE**, COUNTY and PROVIDER hereby agree to amend the AGREEMENT in the following manner:

1. Fourth paragraph in the Background section is being amended as follows: Replace “Pursuant to California Code of Regulations, Title 22, Section 100168(b)(4)” with “Pursuant to California Code of Regulations, Title 22, Section 100096.01(4)”
2. Section 1 of Term of Agreement shall be amended by removing “Once signed by the authorized representatives for all parties, this agreement becomes effective at 12:00 a.m. on July 1, 2018 and shall continue until June 30, 2025,” and replacing it with “Once signed by the authorized representatives for all parties, this agreement becomes effective at 12:00 a.m. on July 1, 2018 and shall continue until June 30, 2028.”

- 4. A copy of AMENDMENT No. 4 shall be attached to the original AGREEMENT dated July 1, 2018 and shall be incorporated therein as if fully set forth in the AGREEMENT.
